Changes to the name, purpose and symbols of the Association

Name of the Association: Systems Leadership Association

Purpose of the SLA: The purpose of the SLA is to assist each other in the understanding and application of Systems Leadership.

SLA Logo: The new logo reflects the original design and introduces some minor updates. Of the two choices, the Operating Committee prefers the second which reflects the lighter blue colour represented in much of our symbolism and suggests a futures orientation.

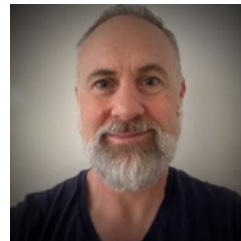
